Resolution #15-038 Confirmation Interest Quotation BAN Renewal Fire Department Vehicle and Equipment

Trustee Akey offered the following resolution and moved its adoption:

RESOLVED, that the Board of Trustees confirm the acceptance of the interest rate of 2.10% submitted by the M&T Bank on the \$69,972.83 BAN Renewal Fire Department Vehicle and Equipment. An additional rate of 2.12% was submitted by Sterling National Bank.

The foregoing was seconded by Trustee O’Leary and was duly adopted by unanimous vote.

Resolution #15-039 Transfer from General Fund to CHIPS Reserve

Trustee Akey offered the following resolution and moved its adoption:

RESOLVED that the Village Clerk Treasurer transfer \$6,652.66 from the General Fund Checking Account held at the M & T Bank to the Various Funds Money Market held at the Sterling National Bank. This money represents the

Resolution #15-040 Transfer from General Fund to the General Fund Money Market

Trustee Akey offered the following resolution and moved its adoption:

RESOLVED that the Village Clerk Treasurer transfer \$200,000.00 from the General Fund Checking Account held at the M & T Bank to the General Fund Money Market held at the Greater Hudson Bank. This transfer represents general fund money being invested.

The foregoing was seconded by Trustee O'Leary and was duly adopted by unanimous vote.

Resolution #15 -041 Transfer General Fund to Debt Service

Trustee Akey offered the following resolution and moved its adoption:

RESOLVED that the Village Clerk Treasurer transfer \$64,857.02 from the General Fund Checking Account held at the M & T Bank to the Debt Service Fund Account held at the Sterling National Bank. This transfer to cover the principal and interest payment due on the Village of Sloatsburg Bond Anticipation Note Various Purposes.

The foregoing was seconded by Trustee O'Leary and was duly adopted by unanimous vote.

Resolution #15-042 Rescinding Resolution #15-021

Trustee Akey offered the following resolution and moved its adoption:

RESOLVED, that the Board of Trustees rescind resolution #15-021 dated 2/20/15. Said resolution declaring the 1999 Ford Expedition vin #1FMPU18L6XLC32971 as surplus (copy of the original resolution is attached)
