Resolution #15-053 Agreement – Rockland Baseball Association Little League Field Use Agreement

Trustee Akey offered the following resolution and moved its adoption:

WHEREAS, RB Association, Inc., desires to enter into an agreement with the Village of Sloatsburg for the use of its little league baseball field for the 2015, 2016 and 2017 baseball seasons, and

WHEREAS, the Village of Sloatsburg desires to allow RB Association the use of said little league baseball field, and

WHEREAS, the terms of the use are as follows:

75 tons of clay will be put in place during the three year period of the contract. If additional clay over the 75 tons is required it will be at the expense of RB Association.

The chemical treatment of the lawn will be covered by Field Pro who currently treats the entire facility.

The lawn will be cut by the Department of Public Works based on their schedule for a fee of \$1,500 per year, payable to the Village at the start of the 2015 season.

The Village will undertake the repair to the gates going into the facility, said gates will not be locked.

The RB Association, at their own expense, will place fence toppers on the fencing going around the little league field.

The little league field will be available to the general public when not in use by the RB Association after consultation with the Village.

The RB Association to submit a yearly schedule.

There will be no subletting of this facility by RB Association while under this contract.

NOW, THEREFORE, BE IT RESOLVED, that the Village Attorney is authorized to draft an agreement subject to the above terms and the Mayor is authorized to execute the same.

The foregoing was seconded by Trustee O’Leary and was duly adopted by unanimous vote.

Resolution #15 -054 Authorization to Execute the 2015 Application for Permit to Operate Sloatsburg Municipal Pool

Trustee Akey offered the following resolution and moved its adoption:

RESOLVED, that the Mayor be given authorization to execute the 2015 application for a permit to operate the Sloatsburg Municipal Pool. Application to be submitted to the Rockland County Department of Health, no later than May 1, 2015, with a fee of \$490.00.

The foregoing was seconded by Trustee O’Leary and was duly adopted by unanimous vote.

Mayor Wright asked Laurie Smyla if she would like to address the Board. Mrs. Smyla commented about the Town of Tuxedo’s Public Hearing regarding the Tuxedo Farms project which she attended. She commented that they are continuing the grading of the road and property near Dater’s pond without permit from the Drainage Agency.

Mr. Ellsworth commented that he will look into the matter and consult the Building Inspector.

Petition Tuxedo Reserve Amending the Permitted Uses in the MU1 Zone

Mr. Ellsworth commented on the petition by Tuxedo Reserve Owner, LLC to amend the Zoning Ordinance of the Village of Sloatsburg. The petition is based on Village Code #54-7 in the MU1 District; to add businesses for professional offices in existing buildings to the permitted uses in that zone. Mr. Ellsworth recommended the matter be referred to the Planning Board and that a Public Hearing be scheduled for more than forty-five days from tomorrow.

On a motion by Trustee Bonkoski, seconded by Trustee O'Leary to authorize the Village Clerk to forward the petition to the Planning Board requesting comment and to authorize the Village Clerk to advertise a Public Hearing on 6/23/15, ten days prior to the hearing. All in favor, motion carried.

Jay Myrow, the attorney representing Tuxedo Farms, provided comments on the petition to expand the uses in the MU1 District, in particular the old Jessie's Bagels building. Andrew Dance, representing Tuxedo Farms, commented that they would like to use the old Jessie's Bagels building for a professional office, not a construction office, where they would conduct meetings for the next five years.

Discussion with Building Inspector in regard to concerns of Building Department

The Building Inspector, Joseph Tichenor, asked about the possibility of issuing summons to people, specifically if they block or park in fire lanes. After a brief discussion, Trustee Bonkoski commented on law enforcement issues and indicated that if there is a problem the Code Enforcer should call Ramapo Police. Trustee Akey clarified Mr. Tichenor should still enforce code violations.

Mr. Tichenor then commented on an application received from a third party electrical inspector who is seeking to provide electrical inspections in the Village. He recommended the Board accept Emmanouil Zervakis of New York Electrical Inspectors, Inc. as a third party electrical inspector.

On a motion by Trustee Buckley, seconded by Trustee O'Leary to approve Emmanouil Zervakis of New York Electrical Inspectors, Inc., dba Inspections on Time, as a third party electrical inspector for the Village of Sloatsburg. All in favor, motion carried.

Mr. Tichenor also commented that he would like to add some public information to the Village website or calendar regarding Village code requirements. This would give residents knowledge before they begin a project. For example, if they want to buy a pool they will know what is allowed by code before they purchase it. Trustee Akey indicated that he could put information on Facebook if the Board agrees.

The next issue that Mr. Tichenor discussed was the \$35.00 re-inspection fee that is in the code but has not been enforced. He would like to start charging the fee and possibly increase the amount depending on how many times a re-inspection is necessary. Trustee Buckley indicated the Town of Ramapo charges \$75.00 for a re-inspection.

Mr. Tichenor then stated that there are some demolition projects coming up and the demo fee is the same minimal amount, regardless of the size of the job. There was further discussion regarding the fees. Trustee Buckley stated that the Town of Ramapo charges the same fee for demolition as they do for the cost of construction.

Mr. Tichenor also talked about the code as it relates to driveways. He is getting a lot of questions from residents who would like to expand their driveways as they need additional parking. He indicated that the code needs to be updated.

Mr. Tichenor stated that according to the DEC, they have to formally appoint a Stormwater Management Administrator. He indicated that he is certified and would be willing to assume the responsibility.

On a motion by Trustee O'Leary, seconded by Trustee Akey to designate Joseph Tichenor as Stormwater Management Administrator. All in favor, motion carried.

Ron Kanasky, 1st Lt. Anthony Butler and 2nd Lt. Robert Stein. All in favor, motion carried.

Mayor Wright also congratulated John Durkin on being elected President of the Sloatsburg Fire Department. He also expressed thanks and appreciation to Joe Hardiman for his many years of service as President of the Department.

Mayor Wright welcomed Town of Ramapo Councilman, Dan Friedman, and invited him to address the Board. Town Councilman Friedman discussed the Fire Protection District coverage and discussion followed.

Village Attorney's Report on various issues

Mr. Ellsworth commented that the Town of Clarkstown is looking into the General Municipal Law that requires adjoining municipalities to comply in the same manner they do with the County Planning Department when they are dealing with putting adjoining municipalities on notice of an improvement.

Mr. Ellsworth also explained the IMAP (Interstate Municipal Plan for Emergency) that does not require any action. For natural or any type of disasters, there is a Federal and State law that puts all municipalities into this program seeking assistance that does not require Village or Town Board action to come and help. There is a reimbursement program from the Federal and State to the municipalities crossing the borders to help the Town or Village in distress. The Mayor asked for and received clarification regarding action. Mr. Ellsworth responded that he will look into it further.

Other

Mayor Wright asked for any comments or questions, none received. He then expressed his sympathy to Mr. Ellsworth on the recent loss of his father. Mr. Ellsworth thanked the Mayor and staff for all of their support. The Mayor then called for a motion to recess to executive session.

On a motion by Trustee Buckley, seconded by Trustee O'Leary to recess the regular meeting and move to executive session at 9:05 PM. All in favor, motion carried.

On a motion by Trustee O'Leary, seconded by Trustee Buckley to come out of executive session and reconvene the regular meeting at 9:10 PM. All in favor, motion carried.
