Minutes

a. Regular Meeting 9/9/14

On a motion by Trustee Akey, seconded by Trustee Buckley to accept the minutes of the regular meeting of 9/9/14. All in favor, motion carried.

b. Regular Meeting 9/23/14

On a motion by Trustee Akey, seconded by Trustee Buckley to accept the minutes of the regular meeting of 9/23/14. All in favor, motion carried.

At this time, Mayor Wright asked the Village Clerk to address the Board regarding the proposed drainage improvements on Hillside Road and Hazelwood Road. Mr. Bollatto commented on the bond resolution that was authorized at the September 9, 2014 meeting. He indicated that he and Mike DeMartino spoke to the D. O. T. and told them that the drainage project was being done in concert with the installation of the sewer system, so it is being classified as reconstruction.

Mayor Wright commented that he received a call from Dan Friedman at the Town of Ramapo in regard to the Ramapo Fire Protection District No. 2 Agreement and the Johnsontown Road Fire Protection District. Mr. Friedman indicated it would be the same as last year. Trustee Buckley and Trustee Akey both indicated they feel we are stuck with what we are getting.

Report on United Water and other concerns

Mayor Wright commented they are moving right along on Route 17. Trustee Buckley commented that they are going to put the 8" line in. He got their response and he disagrees with it. Fire Chief, Joe Vega met with United Water once about the hydrants and there will be a connection for the fire service next to the hydrants. There are things to work out but there is progress.

Mayor Wright commented there was concern from 181 Orange Turnpike about how high the asphalt was over the temporary pipe and United Water responded right away. There was also a great deal of concern from a resident further up Route 17 about the pipes freezing.

<u>Update on The Stables</u>

Mr. Ellsworth commented that responses have not come back from Colonial Surety. There has been no activity from the contractor. There was further discussion regarding the bond.

At this time, Mayor Wright read a letter from St. Joseph's Home requesting temporary shelter in the case of an emergency evacuation. After a brief discussion, the Mayor called for the following action:
