Mayor Akey responded that they could post reminders and projects when they get the future website up and running.

Trustee Donohue also noted that the Trustee's Sloatsburg emails will be turned on shortly and the old email addresses archived. She also indicated that she found Webex to be challenging to set up meetings so she suggested switching to Zoom for the same type of cost and it will be easier to manage. A brief discussion followed regarding executive session.

Trustee Bonkoski asked about the status of Mr. Bruno's building across the street. Mr. Ellsworth indicated that he spoke with Cathy Morris, but she has not gotten back to him. Mr. Ellsworth will inform the Building Inspector to issue a violation and reminded the Board that courts are closed except for criminal court.
