#### Regular Meeting - November 9, 2021

The Regular Meeting of the Village Board of Trustees was called to order at 7:30 PM by the Honorable Peter J. Akey, Mayor, in the Conference Room of the Sloatsburg Municipal Building, 96 Orange Turnpike, Sloatsburg, New York.

Mayor Akey opened the meeting and invited Kathy Goldman to address the Board on behalf of the Friends of Harmony Hall. Ms. Goldman said that the Friends of Harmony Hall are planning their annual Victorian Holiday on Sunday, December 5<sup>th</sup>. They are applying for a sign permit and requesting to have the fee waived. Mayor Akey indicated they cannot waive the fee. They must pay for the sign permit and the Village will refund it.

On a motion by Trustee Donohue, seconded by Trustee Frasier to refund the fee for a sign permit issued to the Friends of Harmony Hall. All in favor, motion carried.

Mayor Akey then invited the volunteers from Spring Hill Ambulance to address the Board. Mr. Efraim, the Chief of Spring Hill, thanked the Board and updated them on their plans. They would like to move into the Sloatsburg Ambulance Building within the next few weeks and the goal is to be stationed here 24/7. He also indicated they would like to rebuild and do community outreach such as, CPR classes for free, first aid classes for free, Narcan training, etc.

Trustee Frasier asked for and received clarification that Spring Hill is trying to regrow the volunteer base in Sloatsburg so that they have volunteers located here and responding here.
