Mayor Akey opened the meeting with the swearing in of Marc Bitterman as Village Trustee. He then proceeded to make the following appointments:

# PROCEDURE FOR SPECIAL MEETINGS

Reference Local Law #3 of 1982 of the Village of Sloatsburg entitled A Local Law Regarding the Convening of Special Meetings of the Board of Trustees of the Village of Sloatsburg which Local Law sets for the procedure for the calling or holding of a Special Meeting of the Board of Trustees. Reference should be made to the fact that the Village of Sloatsburg's Local Law mirrors the Public Officers Law.

On a motion by Trustee Bonkoski, seconded by Trustee Frasier, to approve the procedures for special meetings. All in favor, motion carried.

# ADOPTION OF ROBERTS RULES OF ORDER

Roberts Rules of Order are adhered to during the conduct of any and all Village Board meetings.

# APPROVAL OF CLAIMS

Village Law Section 523(6) provides that the Board of Trustees may, by resolution, authorize payment in advance of audit of claims from public utilities services, postage, freight, and express charges. If the Board of Trustees does authorize payment of these claims before audit, it would be appropriate to do so at the Organizational Meeting, whereas the following resolution should be proposed.

WHEREAS the Board of Trustees has determined to authorize payment in advance of audit of claims for public utilities services, postage, freight, and express charges, and

WHEREAS all such claims shall be presented at the next Regular Meeting for audit, and claimant and officer incurring or approving the same shall be jointly and severally liable for any amount disallowed by the Board of Trustees,

NOW, THEREFORE, BE IT RESOLVED:

- 1. That the Board of Trustees authorizes payment in advance of audit of claims for public utilities services, postage, freight, and express charges and all such claims shall be presented at the next Regular Meeting for audit and claimant and officer incurring or approving the same shall be jointly and severally liable for any amount disallowed by the Board of Trustees.
- 2. That this resolution shall take effect immediately.

Trustee Bonkoski offered the foregoing resolution. Trustee Frasier seconded the adoption of this resolution. All in favor, motion carried.

# **MILEAGE ALLOWANCE**

Village law Section 5-523(7) provides that the actual and necessary expenses of all officers and employees incurred in the official duties shall be a Village charge. Trustees should be allowed, as determined by resolution, to pay a reasonable mileage allowance for use of personal automobiles in the performance of official duties. It is appropriate to adopt this policy at the Reorganizational Meeting the following resolution should be proposed:

WHEREAS, the Board of Trustees has determined to pay a fixed rate for mileage as reimbursement to officers and employees of the Village who use their personal automobiles while performing their official duties on behalf of the Village.

NOW, THEREFORE, BE IT RESOLVED:

- 1. That the Board of Trustees shall approve reimbursement to such officers and employees at the current rate of 0.58.5 cents per mile, subject to change 1/1/2023.
- 2. That this resolution takes effect immediately.

Trustee Frasier offered the foregoing resolution. Trustee Donnelly seconded the adoption of this resolution. All in favor, motion carried.

# **PROCUREMENT POLICY**

WHEREAS the General Municipal Law Section 103-b requires that all municipalities adopt procurement policies for goods and services which are not required by law to be publicly bid, the Board of Trustees should simply acknowledge that there exists a previously adopted resolution regarding Procurement Policy for the Village of Sloatsburg which said policy went into effect on 04/07/2022 and should be renewed and reviewed annually. At this point, the Board should simply renew the currently existing Procurement Policy for the Village of Sloatsburg and should adopt same.

On a motion by *Trustee Bonkoski*, seconded by *Trustee Frasier*, to approve the existing Procurement Policy for the Village of Sloatsburg. All in favor, motion carried.

RESOLVED, that the rate currently charged by Orange & Rockland is 9.0660 ccf which was in effect for November of 2022, and

BE IT RESOLVED that the rate be effective November of 2022 is \$0.058710 ccf for a 48 month period which expires November, of 2026, and

BE IT FURTHER RESOLVED, that the Board of Trustees authorizes the Village Clerk/ Treasurer to execute an agreement with Hudson Energy Services.

#### Attorney's Report

Mr. Ellsworth reported that he is working on a draft local law with respect to the registration of rental homes in the Village. He asked the Board how they would like to proceed, and discussion followed.

Mr. Ellsworth also commented that the Planning Board has not acted on the license agreement in the Bruno matter.

Trustee Bonkoski thanked the Building Inspector and the Village Attorney for staying on top of the property formerly known as Tuxedo Motor Sports which is now being used for storage.

Mr. Ellsworth noted that Tuxedo Motor Sports and the property on Eagle Valley Road were both settled in court with terms of paying a fine, getting a building permit and/or a Planning Board application within thirty (30) days. Neither has complied so both were sent notices to reappear in court and the charges will be reinstated.

#### Trustee Frasier Report on the Veteran's Turkey Distribution

Trustee Frasier reported that they provided fifty turkeys, forty-seven went to Veterans and three to the food pantry. They will have another holiday distribution on 12/17/22, 10:30 AM to 11:30 AM.
