# <u>Resolution #24-15 Refund – Village Taxes – Reduction of Assessed Value for 2023 Assessment Roll</u>

Trustee Frasier offered the following resolution and moved its adoption:

WHEREAS, the Village is in receipt of an Order and Judgement for Reduction of Assessed Value for 2023 Assessment on Parcel ID #39.29-1-17; and

WHEREAS, the assessment on Parcel ID #39.29-1-17 was reduced from \$47,500.00 to \$39,100.00 for a total reduction of \$8,400.00; and

NOW, THEREFORE, BE IT RESOLVED that the Village Clerk & Treasurer refund \$351.05, representing the overpayment of taxes.

### Resolution #24-16 Refund – Village Taxes – Reduction of Assessed Value for 2019-2020 Assessment Roll
