Mayor Akey confirmed with the Village Clerk that the Notice of Public Hearing was published and posted properly.

On a motion by Trustee Bonkoski, seconded by Trustee Donnelly to open the public hearing. All in favor, motion carried.

Mayor Akey opened the public hearing and reviewed the proposed Local Law #2 of 2023 Amendment to Certain Real Property Tax Exemptions. The Mayor noted that there was no public attendance.

On a motion by Trustee Bonkoski, seconded by Trustee Donnelly to close the public hearing. All in favor, motion carried.

Mayor Akey called for a motion to open the second public hearing on proposed Local Law #3 of 2023 and confirmed that all notifications were posted.

On a motion by Trustee Donnelly, seconded by Trustee Bonkoski to open the public hearing at 7:15PM. All in favor, motion carried.

Mayor Akey opened the public hearing on proposed Local Law #3 of 2023 Property Ownership Registration Law. He noted that there was no one from the public in attendance.

For the record, Mayor Akey read the following changes that were made to the local law:

PROPOSED OWNER – Any Person as defined herein who enters into a contract to purchase Property and who requests a copy of a certificate of occupancy and/or copies of any open violations for the Property from the Building Department of the Village of Sloatsburg, whether by a freedom of information request or for a fee. Registration requirements.

B. Each Proposed Owner of Property within the Village of Sloatsburg, as herein defined, shall be required to file with the Building Department of the Village of Sloatsburg, on a form to be prescribed by the Village of Sloatsburg, the name, address and telephone number of an individual authorized to act on behalf of the Owner in matters concerning the management and operation of the Property of the Owner ("Authorized Individual") in the event the Proposed Owner becomes the Owner, in relation to the Village of Sloatsburg including, but not limited to, the acceptance of service of notices and Process. The Building Department is authorized to withhold compliance with the Proposed Owner's request of a copy of a certificate of occupancy and/or copies of any open violations for the Property until the Proposed Owner complies with the provisions of this Local Law.

C. The individual designated in Subsection A and Subsection B above shall reside in Rockland County. This individual shall, by such designation, be authorized to bind the owner to any settlement, fine, judgment or other disposition, other than incarceration, which may result from any civil or criminal action or proceeding instituted by the Village of Sloatsburg against said owner.

Fees.

The filing fee for each property registration and rental registration shall be \$50.00, which fee may be increased in accordance with the Fee Schedule of the Village of Sloatsburg.

On a motion by Trustee Bonkoski, seconded by Trustee Donnelly to close the Public Hearing. All in favor, motion carried.

Stewart Farms Presentation

Mayor Akey invited Mr. Emanuel to provide the Board with an overview of the Stewart Farms project. Mr. Emanuel indicated that the proposed project would require a change to the Village Zoning Code. He asked the developer, Mike Abuladze, to express his vision for the property.

Mr. Abuladze spoke about his interest in the parcel and his vision of one and two bedroom apartments with a luxury feel, but still affordable. Discussion followed regarding the zoning.

Ann Cutignola, the planning consultant, discussed the proposed project including options that could be removed.

Mr. Emanuel explained that they wanted to make an informal presentation to find out if there is any interest.

Mayor Akey thanked them for coming and suggested that they move forward with the process.
