Resolution #21-052 Funds Transfer

Trustee Donohue offered the following resolution and moved its adoption:

Other

Ms. Jessie Taylor, a Sloatsburg resident, stated that she has been putting on a "Plein Air Event" along with the Sloatsburg Chamber of Commerce and Friends of Harmony Hall to get people to come to Sloatsburg. The event enables people to see different sites of historical value, visit and support local businesses. Artists are also invited to paint live or perform their art in person, as long as it does not harm the environment, so people can observe throughout the day. The event will take place sometime in May and runs from 10:00 am to 5:00 pm. Ms. Taylor indicated she has applied for grants to offset costs. She asked the Board if the artists would be able to display their work either in the fire hall or municipal building and discussion followed.

Marianna Krichevsky, a member of the Chamber of Commerce, presented the idea of having free summer concerts at Mill Street Park on the weekends. There was further discussion on incorporating sponsors, vendors, and food trucks etc.
