# **FINAL** MEETING MINUTES VILLAGE OF SLOATSBURG ZONING BOARD OF APPEALS

# April 20, 2023

The Village of Sloatsburg Zoning Board of Appeals Board Meeting was called to order on April 20, 2023 at 7:30 pm by Chairman Gus Stritmater.

Chairman Stritmater opened the meeting with the Pledge of Allegiance.

# Jason Fox – 61 Eagle Valley Road

A motion was made by reopen the Public Hearing by Stephen Hoefer and seconded by Bill Samora. All in favor. Motion carried. The Public Hearing is opened.

Mr. Fox presented his revised application where the building width was decreased to save an additional five feet into the setback. The carport shape changed to an open structure with the footprint along the property line, five feet away and will not require a variance.

The public was asked for comments.

Michelle Morgan, 62 Eagle Valley Road, Apt. 2 Asked about meeting minutes and meeting notices Objected to water zone/flood area, setbacks, variances Village Attorney responded that meeting notices are posted, not sent out to neighbors.

Dolores Morgan, 62 Eagle Valley Road
Asked if the application would appear in the Planning Board
Feels house has already been extended and lot is not large enough for all of the plan
Village Attorney responded that this application does not have to go through Planning
Board. No additional comments will be heard after closing of the Public Hearing.

A motion was made to close the Public Hearing by Stephen Hoefer and seconded by Kevin Camilleri. All in favor. None opposed. Motion carried. Public Hearing is closed.

Chairman Stritmater asked for Board member comments.

Village Engineer asked why carport was not squared off. Applicant stated it was not needed. Engineer stated plan changes—shed has been shifted, topo added by surveyor, water going across property to Nakoma Brook, dry well shown for carport, gravel surface by carport would be a better choice for the .07 acres which is physically disturbed, must have erosion control during building.

Chairman Stritmater asked if drawings were submitted to the Building Department and Drainage Agency.

Village Attorney stated appeal is on denial of Building Department. If appeal is granted then applicant would go to the Building Department and other required agencies.

Changes to be made on applicant's Short Environmental Assessment Form: If vote goes in the applicant's favor, this form can be corrected then.
